Sir,

This has reference to appeal dated 18-03-2015 filed by you against Provisional Accreditation of PGDM and PGDM (International Business) programs of your Institution.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 17-12-2015. The recommendation of the Appellate Committee was considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the program is given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Birla Institute of Management Technology, Greater Noida, Uttar Pradesh as a whole**. As such the Institution should nowhere along with its name including on its letter head etc., write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name and level of the program accredited and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
