MAIN POINTS OF DISCUSSION :-

Dr. Anuj Sharma welcomed all members present in the room and requested everyone to introduce themselves for the benefit of other members and start discussions related to the five main agenda points set for the meeting.

1. H E Asfaw Dingamo, Ambassador,

Embassy of Federal Democratic Republic of Ethiopia

- He said that Flexibility of the program and benchmarking with other Institutes was a very good initiative and required so as to make it excellent. He suggested that Programme should identify the areas of improvement during benchmarking.
- Program should have strong industry linkage as done in Technical and vocational courses in Germany.
- In dynamic environment subjects like Geopolitics and Global Business Environment should be constantly updated.

2. H.E. Dalton Sembiring, Minister, Deputy Chief of Mission,

Embassy of the Republic of Indonesia

- He laid emphasis on Cultural aspects of business.
- Students should be exposed to the nuances of culture and sub-culture of important countries with which India has business relations.

3. Mr. Asalf Habtegiorgis, Minister Counselor I (Education),

Embassy of Federal Democratic Republic of Ethiopia

- He laid emphasis on conducting guest lectures' from Embassies.
- He offered to link Institute with Industry for doing activities like Short Term Projects, Summer Internship Programme etc.
- He also added that we should have faculty exchange and student exchange with African Countries.

4. Mr. Anil Gupta, Head: Strategic Alliances & Client Engagement, Arthimpart Finserv

- He stressed on Entrepreneurship and Start-Ups. Focus should also be on knowing why Startup's fail! One should go deeper as we are still in ideation stage and need to move faster on the same. He stressed that students should be exposed to factors that leads to failures of Startups.
- IB programme should develop a niche for itself so that students and faculty would wish to come here as they aim for Harvard or IIM's.
- IB Programme should increase collaborations with industry for activities like MDP's and Consultancy.
- IB Programme should collaborate with Universities and Institutes in different countries for conducting joint research, seminars etc.
- IOT should be dealt in detail so that students are ready to use its tool when they enter into the industry.

5. Prof. Cherian George, Professor & Head – MDP Cell,

Jagan Institute of Management Studies (JIMS), Rohini

- He focused on having a proper structure for doing and evaluating Summer Internship Programme.
- SIP's and live projects should also be explored with bodies like Ministry of Commerce, DGCIS, DGFT, MEA, FIEO and Embassies and Consulates.

6. Mr. Jairam Shetgaonkar, VP –International,

Godfrey Phillips India Ltd

1. He stressed on creating entrepreneurs.
2. He emphasized on Persuasive Leadership and communication skills in international context
3. Focus should be on building effective international teams that consistently delivers
4. He stressed on building key essential international managerial skills and transformational decision making
5. Students should develop skills on how to deal with Conflict in international context and its resolutions.
6. On roadmap for future, he said that students should be exposed to International startups.

**7. Mr. Praveen Tandon, Head- Exports & DGM,
LG Electronics India Pvt. Ltd.**

- Students should be thoroughly prepared before taking Summer Internship. This may help student in getting Pre-Placement Offers.
- He emphasised on understanding culture of different countries to be able to operate successfully in those markets.
- He offered to give real case-studies to help students to work and propose possible solutions.

**8. Mr. Rajiv Kumar, Executive Director,
BSL Gulf**

- Students should be able to analyze the factors for success and failure of businesses and startups.
- Focus should be given more on Africa as there are immense opportunities available in African markets.

**9. Mr. Rajiv Wahi, Head-International Business,
Escorts Agri Machinery**

- Digital Marketing is need of the day in every industry and should be focused and emphasized for students.
- Through curriculum, students should also be trained to have entrepreneurial mindset, which may help them in understanding entrepreneurial activities in future.

**10. Dr. S. P. Sharma, Chief Economist & Head of Research,
PHD Chamber of Commerce & Industry**

- He stressed on sharing Summer Internship Reports with Industry. He offered to support this through PHD Chamber of Commerce & Industry.
- Students should be encouraged to write policy related case-studies.

- Should increase interface with Industry for of Short term projects and Summer Internships. He offered to take students for Short Term Projects and Research projects at PHD Chamber of Commerce & Industry for training students.
- Industry experts should be invited for exposing students on contemporary issues in area of International Business & Trade.

**11. Mr. Vijendra G. Gupta, Senior Associate Vice President, Spare Parts & International Business (Tractor & Engine),
Eicher Tractors**

- He focused on practical knowledge for students.
- Students should be thoroughly prepared for Summer Internships to get the desired results.
- Students should be prepared for a career rather than first job.
- He emphasized on imparting IOT knowledge to students.

12. Mr. Y. K. Lee, CEO,

Korea India Business Development Centre Pvt Ltd (KIBC)

- He said that Korean's manufacturing is strong and are keen on having tie-up with Indian Companies. Also South Korean academic Institutions are keen on forging relations with India. He offered to help in collaboration of IB Programme with Korean Universities and Industry.
- BIMTECH can look for Student and Faculty Exchange with industry and South Korean Universities.
- South Korean companies are presently focusing on areas like Robotics, ICT and Biotech. IB Programme can be involved in management of these key areas through programmes, seminars, research etc.

POINTS OF DISCUSSIONS – GROUP 2 (Conference Room)

MAIN POINTS OF DISCUSSION :-

Dr. Anupam Varma welcomed all members present in the room and requested everyone to introduce themselves for the benefit of other members and start discussions related to the five main agenda points set for today's meeting.

1. H.E. Elizabeth Napeyok, High Commissioner, Embassy of Republic of Uganda

- She pointed out that Exchange students from Africa should be extended from PhD students to MBA program students.
 - She was looking at study exchange programmes for students from Uganda so as to know India and its trade / economy.
- 2. H.E. Mohamed Ali Osman, Counsellor Education, Kenya High Commission**
- He also added that we should have faculty exchange and student exchange with African Countries.
- 3. Ms. M M M Makgoba, Counsellor Political, High Commission of South Africa**
- She was of the view that the institute should be ready for random visits of education delegations of foreign countries.
- 4. Mr. Witness Ngwenya, Counsellor, Embassy of the Republic of Zimbabwe**
- He stressed that BIMTECH should encourage engagement with Zimbabwe and invite academicians and students to the institute. He said that several higher educational institutes can be approached for collaborations.
- 5. Mr. Ajay Agarwal, Director-Operations, Alcatel-Lucent India Ltd.**
- He raised his concern with respect to the effectiveness of Short Term Projects.
 - He emphasized on involvement of rigor and quality of interaction during Short Term and live projects.
 - He also recommended a regular industry interaction and involvement for better results.
- 6. Mr. G.C.Mondal, Director – F&A, Company Secretary, IDFC Foundation**
- He recommended for exposing students to GST and its applications.
 - He also suggested including GST as core subject or modules of GST in finance and operations specialization.
 - He emphasized that the relevance of GST in international business should be told to students.
- 7. Mr. M. R. Rajaram, Advisor, Akzo Nobel India**
- He stressed on including feedback from alumni to measure the gap in courses.

- He was of the view that greater emphasis should be given on ethics and compliances.
- He pointed out that outgoing students in exchange programs should be aimed at 20%.

8. Mr. Malik Shah, Vice President - Commercials and Supply Chain, PI Industries Ltd.

- He emphasized the role of short term projects in experiential learning and continuous monitoring for better results.

9. Mr. Nirmal Sinha, ex CMD, The Handicrafts & Handlooms Exports Corporation of India Ltd.

- He was of the view that participation in global competitions for better visibility of program, interaction with industry leaders for developing communication skills, STPs should not be half-cooked and should have better monitoring mechanisms.
- He further said that focus should be made on country "Africa" in terms of modelling the curriculum and getting students and faculty from Africa. The institute's nodal person should be communicated with all the embassies in Africa.
- He said that there are two views on policy changes – government and Chambers & Consultants

10. Mr. Pranav Kumar, Director & Head International Trade, Confederation of Indian Industry

- He recommended involvement of courses on Standards & Sanctions in international business with focus on scenario e.g. Quality standards/BIS/DOC/FSSAI and changes in standard value chains.
- He also extended a helping hand to support PGDM IB by connecting the program students with standard setting agencies wherein BIMTECH could partner with Government of India in their various campaigns.
- He further stated that Department of Commerce Officials should be contacted for education specific trade fairs; Engagement with United Nations for Africa engagement.
- His views were also on more guest lecturers from Government bodies like Ministry of Commerce, IIFT, RIS for enhanced engagement with policy making bodies which keep an eye on the global developments. Project/report writing and research by students is preferred.

11. Mr. Ramesh Krishnan, President, Distribution, Logistics & Infrastructure Ltd.

- He suggested enhanced involvement of students with industry and more application oriented exposure.

- He recommended six months of internship with industry on live projects.
- He also recommended involvement of students on regular or part time projects in consultancy projects and research.

**12. Mr. S. C. Pradhan, CEO,
S4 Enterprises**

- In his view students should be exposed to projects based on product standards and quality and that interaction with business houses and institutions should be initiated in this regard.
- The Best practices of CSR [as mentioned in the company law as social responsibility of business] should be shared with the students.
- Students should be encouraged for studying Trade Agreements with specific regions should be studied for business start-ups in future. Students should be given
